Bankruptcy Judges, where he served as President from 1985 to 1986. In 1980, Ralph Kelley was appointed to the Committee on the Budget of the Judicial Conference of the United States, where he served until 1990. The

Biography/History

Ralph H. Kelley was born in Chattanooga, Tenn. in 1928. Following his service in the Air Force during World War II, Kelley graduated from Vanderbilt University Law School. From 1959 to 1961 he served in the Tennessee House of Representatives before his election as Mayor of Chattanooga in 1963. Kelley was appointed United States Bankruptcy Judge in the Sixth Federal Judicial Circuit in 1969. In 1993 he retired as Chief Judge of the Bankruptcy Court for the Eastern District of Tennessee but remained the court's senior judge. He was a career-long member of the National Conference of Bankruptcy Clerks and the National Conference of Bankruptcy Judges, where he served as President from 1985 to 1986. In 1980, Ralph Kelley was appointed to the Committee on the Budget of the Judicial Conference of the United States, where he served until 1990. For over thirty years, Kelley used his experience and clout as a respected bankruptcy judge to lobby various congressional committees on behalf of bankruptcy reform and improved financial compensation for bankruptcy judges.
